BIG BASKET DROP SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR SCAN NECESSARY. A PURCHASE OR SCANNING WILL NOT IMPROVE YOUR CHANCES OF WINNING.

OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, AND PUERTO RICO, 21 YEARS AND OLDER.

The Big Basket Drop Sweepstakes (the "Sweepstakes"), sponsored by Mondelēz Global LLC ("Sponsor"), begins at 12:00 a.m. Eastern Time ("ET") on April 1, 2025 and ends at 11:59 p.m. ET on April 30, 2025 (the "Sweepstakes Period").

1. TO ENTER: If you choose to register and enter using a mobile device, standard message and data rates may apply in accordance with your personal mobile service plan. Check details of your plan prior to using a mobile device to enter. A mobile device is not required to participate. During the Sweepstakes Period, scan the QR code made available on marketing materials or visit bigbasketdrop.com ("Website") directly on your mobile device or computer. The first time you visit the Website, follow the links and instructions to accurately complete and submit the registration form, including your full first and last name (initials are not sufficient), date of birth, email address, and home address (P.O. Boxes are not permitted). You will receive one Sweepstakes entry. On subsequent visits to the Website, you need only provide your email address.

Limit: One (1) Sweepstakes entry per person per day during the Sweepstakes Period. Use of any robotic, automatic, programmed, or similar entry method, or the use of any means (such as using more than one (1) email address) to obtain more than the stated number of Sweepstakes entries will void all Sweepstakes entries of the person responsible for such action and result in their disqualification from the Sweepstakes. Released Parties (as defined in Section 6, below) are not responsible for lost, late, incomplete, invalid, unintelligible, misdirected or otherwise non-compliant Sweepstakes entries, all of which will be disqualified. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator (as defined in Section 2, below) will rely on the information submitted by the entrant to register for this Sweepstakes. 3. SWEEPSTAKES DRAWING: Administrator is an independent organization whose decisions as to the selection of potential winners are final and binding. Administrator will select the potential
